An administration fee of HK\$300 per paper will be incurred for unqualified applications which do not fulfill the pre-requisite education requirements (5 passes in any subjects in HKCEE/degree holder and prerequisite education modules) for enrolling in any specific examination paper.
- 5. In case of medical or other emergencies, you may apply for a waiver of the examination fee forfeiture. If approval for deferral is granted, candidate will only be allowed to take the next available examination and will be charged an administration fee of HK\$500 per paper.
- 6. If you are a challenge status candidate, you will be charged a one time only assessment fee when you first apply to take the examination. The fee is non-refundable and non-transferable.

INTERNATIONAL RECIPROCITY

International reciprocity refers to the arrangement for candidates who hold a valid CFP certification from the Certified Financial Planner Board of Standards Inc. (CFP Board), or one of the affiliate members of the Financial Planning Standards Board Ltd. (FPSB). Such candidates, after completing an approved education program, are eligible to sit the Cross Border CFP^{CM} Certification Examination which is a 4-hour examination. For details of the pre-requisite requirements, please refer to the Application Form for the Cross Border CFP^{CM} Certification Examination available on IFPHK's website.
