<p>Preparation</p> <ul style="list-style-type: none"> - Check that the personal data on Members' Area is correct. (Failure to provide IFPHK with the correct information by the stated deadline which results in a re-issuance of admission card will incur administration charge of HK\$300 to the examinee.) - Check that the information printed on your admission card is correct. If not, please contact IFPHK immediately. - Read the Examination Regulations inside the Examination Handbook: CFP® certification examination carefully. - Check all your things to be brought to the exam, bring only necessary items. (see Section 2 above) - Consider how many approved calculators to be brought to the exam, and whether their battery levels are OK. (see Section 2.2 above) - Plan your journey to the exam venue.
