## Application for Concessionary Fee Arrangements for Candidacy under “Fast-track to CFP Certification” - List A (for Local Full-time Undergraduate Students)

### Points to Note:

#### 1 Candidacy under “Fast-track to CFP Certification” (List A)

1.1 Individuals with a bachelor degree awarded by an accredited institution may apply for candidacy under “Fast-track to CFP Certification” (List A). Upon approval, they may apply for taking the CFP Certification Examination (Foundation Level).

After passing the CFP Certification Examination (Foundation Level), if they possess one year of qualified work experience and agree to abide by the IFPHK’s Code of Ethics and Professional Responsibility, they may apply to become an AFP Certificant. Alternatively, they may maintain a valid candidacy status. With a valid AFP certificant or candidacy status they may proceed towards CFP certification.

1.2 Students who are taking a bachelor degree program may apply for “Fast-track to CFP Certification” (List A) candidacy. Conditional approval may be granted by IFPHK. Upon conditional approval, they may apply for taking the CFP Certification Examination (Foundation Level) (even prior to completion of the bachelor degree program).

1.3 Students with conditional approval must submit their transcript / certificate to IFPHK within six month after completion of the bachelor degree program. IFPHK will then change their status from “conditional approval” to “approved”.

The passing of the CFP Certification Examination (Foundation Level) will only be accepted by IFPHK as valid for meeting the examination requirement for AFP certification after it has provided “approved” status for the candidacy under “Fast-track to CFP Certification” (List A).

1.4 For students who cannot complete the bachelor degree program, or fail to submit transcript / certificate to IFPHK within six months after completion of the bachelor degree program, the CFP Certification Examination (Foundation Level) result will be nullified.

#### 2 Standard Fee

2.1 To apply for candidacy under “Fast-track to CFP Certification” (List A), normally an applicant needs to pay

- application fee (HK\$300)
- “Fast-track to CFP Certification” assessment fee (HK\$1,000)
- candidacy annual fee (HK\$500 per year)

#### 3 Concessionary Fee

3.1 From 2013, IFPHK offers concessionary fee arrangements for Hong Kong students (please see 3.2 for details). Under the arrangements, the “Fast-track to CFP Certification” assessment fee is reduced to HK\$500. The candidacy annual fee is waived until 31 December of the year of completion of the bachelor degree program.

3.2 Only **BONA FIDE** full-time students who are taking up a face-to-face undergraduate degree program in any discipline at one of the following Hong Kong institutions\* are eligible to apply for the concessionary fee arrangements.

3.3 Students who do not qualify for the concessionary fee arrangements will have to pay the Standard Fee when applying for candidacy under “Fast-track to CFP Certification” (List A).
