March 2018 CFP^{CM} Certification Examinations Results Release

(Hong Kong – 25 April, 2018) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the March 2018 CFP certification examination (Foundation Level) and CFP certification examination (Level 1) held on 17 March 2018. Examinees’ background and their performance are summarized below:

March 2018 CFP Certification Examinations

Pass Rate	The CFP certification examination (Foundation Level) recorded an impressive pass rate of 84.85% while 50% of examinees passed the CFP certification examination (Level 1).
Meritor / Top Scorer	13 examinees attained Merit status in the CFP certification examination (Foundation Level).
Education Level	Over 83% of the total examinees possess a Bachelor’s Degree or above.
Industry Background	In both examinations, over 89% of the examinees in CFP certification examination (Foundation Level) are employees of banking, insurance and independent financial advisory sectors, whilst CFP certification examination (Level 1) recorded over 91%.
Age	More than 75% of the total examinees are between 20 and 39 years old.
