June 2015 CFP^{CM} Certification Examinations (Foundation Level, Level 1 and Level 2) Results Release

(Hong Kong – 17 August, 2015) – The Institute of Financial Planners of Hong Kong (IFPHK) today announces the results of the CFP Certification Examination (Foundation Level), CFP Certification Examination (Level 1) and CFP Certification Examination (Level 2) held in June 2015:

Pass Rates - The CFP Certification Examination (Foundation Level) and CFP Certification Examination (Level 2) recorded similar pass rates of 52% and 57% respectively, whilst 42% of the examinees in the CFP Certification Examination (Level 1) passed the examination.

Meritors and Top Scorers – Six examinees attained Merit status in the CFP Certification Examination (Foundation Level). One examinee was awarded with Top Scorer status in the CFP Certification Examination (Level 2).

Examinees' Education Level – Around 87% of the total number of examinees possess a bachelor's degree or above.

Examinees' Industry Background – Of the three examinations, over 78% of them are employees of banking, insurance and independent financial advisory sectors.

Examinees' Age – Of the three examinations, the CFP Certification Examinations (Foundation Level and Level 1) recorded similar percentages of 87% and 82% of examinees who are in the age range between 20 and 39. In the CFP Certification Examination (Level 2), 77% of the examinees are aged between 20 and 39.
