September 2016 CFP^{CM} Certification (Foundation Level and Level 1) Examination Results Release

(Hong Kong – 28 October, 2016) – The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the September 2016 CFP Certification Examination (Foundation Level) and CFP Certification Examination (Level 1). Both examinations were held on 10 September 2016. Examinees' background and their performance are summarized below:
