# December 2016 CFP<sup>CM</sup> Certification Examinations Results Release

(Hong Kong – 6 February, 2017) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the December 2016 CFP Certification Examination (Foundation Level), CFP Certification Examination (Level 1) and CFP Certification Examination (Level 2) held on 17 December 2016. Examinees' background and their performance are summarized below:

December 2016 CFP <sup>CM</sup> Certification Examinations	
Pass Rate	In the three examinations, examinees of the CFP Certification Examination (Foundation Level) achieved an impressive pass rate at 69.23%, whilst CFP Certification Examination (Level 1) and CFP Certification Examination (Level 2) recorded similar pass rates of 52% and 56.47%.
Meritor / Top Scorer	18 examinees attained Merit status in the CFP Certification Examination (Foundation Level). 1 examinee was awarded with Top Scorer status in the CFP Certification Examination (Level 2).
Education Level	Over 83% of the total examinees possess a Bachelor's Degree or above.
Industry Background	Of the three examinations, over 90% of them are employees of banking, insurance and independent financial advisory sectors.
Age	Around 80% of the total examinees are between 20 and 39 years old.
