## June 2017 CFP<sup>CM</sup> Certification Examinations Results Release

(Hong Kong – 25 July, 2017) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the June 2017 CFP Certification Examination (Foundation Level), CFP Certification Examination (Level 1) and CFP Certification Examination (Level 2) held on 17 June 2017. Examinees' background and their performance are summarized below:

## June 2017 CFP<sup>CM</sup> Certification Examinations

Pass Rate	In the three examinations, examinees of the CFP Certification Examination (Foundation Level) recorded similar pass rates of 64.52% and 64.1%, whilst CFP Certification Examination (Level 2) has a pass rate of 38.57%.
Meritor / Top Scorer	10 examinees attained Merit status in the CFP Certification Examination (Foundation Level).
Education Level	Over 83% of the total examinees possess a Bachelor's Degree or above.
Industry Background	Of the three examinations, approximately 90% of them are employees of banking, insurance and independent financial advisory sectors.
Age	Around 75% of the total examinees are between 20 and 39 years old.
