September 2018 CFP^{CM} Certification Examinations Results Release

(Hong Kong – 23 October, 2018) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the September 2018 CFP Certification Examination (Foundation Level) and CFP Certification Examination (Level 1) held on 15 September, 2018.

Examinees' background and their performance are summarized below:

September 2018 CFP Certification Examinations

Pass Rate	The CFP certification examination (Foundation Level) recorded an impressive pass rate of 72.73% while 65.85% of examinees passed the CFP certification examination (Level 1).
Meritor	11 examinees attained Merit status in the CFP certification examination (Foundation Level).
Education Level	Over 85% of the total examinees possess a Bachelor's Degree or above.
Industry	In both examinations, approximately 90% of the examinees are employees of banking,
Background	insurance and independent financial advisory sectors.
Age	More than 84% of the total examinees are between 20 and 39 years old.
