December 2019 CFP^{CM} Certification Examinations Results Release

(Hong Kong – 4 February, 2020) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the December 2019 CFP Certification Examination (Foundation Level), CFP Certification Examination (Level 1) and CFP Certification Examination (Level 2) held on 14th December, 2019.

Examinees' background and their performance are summarized below:

December 2019 CFP^{CM} Certification Examinations

| Pass Rate | The CFP certification examination (Foundation Level) recorded a pass rate of 73.17% while 68.29% of examinees passed the CFP certification examination (Level 1) and 37.76% of examinees passed the CFP certification exam (Level 2). |
| Meritor | 16 examinees have attained Merit status in CFP certification examination (Foundation Level) while 1 examinee attained Top Scorer status in the CFP Certification Examination (Level 1). |
| Education Level | Approximately 82.8% of the total examinees possess a Bachelor's Degree or above. |
| Industry Background | Of the three examinations, around 91% of the examinees are employees of banking, insurance and independent financial advisory sectors. |
| Age | Around 80% of the total examinees are between 20 and 39 years old. |
