June 2020 CFP^{CM} Certification Examinations Results Release

(Hong Kong – 30 July, 2020) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the June 2020 CFP Certification Examination (Foundation Level), CFP Certification Examination (Level 1) and CFP Certification Examination (Level 2) held on 13 June, 2020.

Examinees' background and their performance are summarized below:
