June 2013 Certification Exanimations Results Release

(Hong Kong— 26 August, 2013) The Institute of Financial Planners of Hong Kong ("IFPHK") today announced the results of its certification examinations held in June 2013. The examinations were the AFPTM Certification Examination, the New Structure CFP^{CM} Certification Examination (Level 1 and Level 2), and the last series of the Old Structure CFP Certification Examinations.

Mr. Dennis Lau, Chief Executive Officer of IFPHK is pleased to announce the excellent results achieved. "Examinees of the June 2013 AFP Certification Examination have continued to achieve an average pass rate of over 60% since the launch of the examination in 2011. This suggests that most examinees are well prepared for the examination. As the future pillars of the financial planning industry, we hope that these new talents will keep striving for excellence and contribute to the profession."

"Impressive results are also seen in the June 2013 New Structure CFP Certification Examination (Level 1) with a pass rate of 60%, and the CFP Certification Examination (Level 2) with a pass rate of 53%. We are also very glad to report that examinees who took the Old Structure CFP Certification Examinations have fared exceptionally well, despite that these are the last examination series. This shows examinees' commitment to aim for the best, and will help bolster the standards of the financial planning profession," says Lau.

In July 2011 a progressive pathway to CFP certification was introduced with a brand new program. Under the new program the AFP certification was introduced as a progressive pathway to CFP certification. The New Structure CFP Certification Examination was also revamped and now consists of two papers, Level 1 and Level 2. Individuals under the Old Structure CFP certification program must complete the certification by 30 September 2013, or convert to the New Structure before that date.

Certification under the Old and New Structures requires CFP professionals and AFP professionals to satisfy the rigorous "4E" certification requirements. These are Education, Examination, Experience and Ethics. The"4E" certification requirements assure the public that they are receiving the best objective and professional financial planning advice.
