# SCMP/IFPHK Financial Planner Awards 2014 (Practitioner Category) Opens for application

(25 March, 2014 – Hong Kong) Jointly organized by the Institute of Financial Planners of Hong Kong (IFPHK) and the South China Morning Post, the signature annual event – "Financial Planner Awards 2014" is in its 10<sup>th</sup> anniversary this year and is inviting applications for Practitioner Category. Application for the Practitioner Category will close on 23 April while all grand prize winners will be unveiled at the awards presentation ceremony to be held in mid-October 2014.
