June 2024 CFP® Certification Examinations Results Release

(Hong Kong – 26 July, 2024) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the June 2024 CFP® Certification Examination (Foundation Level), CFP® Certification Examination (Advanced Level Paper 1) and CFP® Certification Examination (Advanced Level Paper 2) held on 15 June, 2024 in Hong Kong and Macau.

Examinees' background and their performance are summarized below:

June 2024 CFP® Certification Examinations

Pass Rate	The CFP® certification examination (Foundation Level) recorded a pass rate of 73.75% while 53.06% of examinees passed the CFP® certification examination (Advanced Level Paper 1) and 37.84% of examinees passed the CFP® certification exam (Advanced Level Paper 2).
Meritor	7 examinees have attained Merit status in CFP® certification examination (Foundation Level) and 1 examinee has been awarded Top Scorer status in CFP® Certification Examination (Advanced Level Paper 1).
Education Level	Approximately 90.36% of the total examinees possess a Bachelor's Degree or above.
Industry	Of the three examinations, around 75.9% of the examinees are employees of
Background	banking, insurance and independent financial advisory sectors.
Age	Around 69.88% of the total examinees are between 20 and 39 years old.
